GENERAL PROGRAM PARTICIPANT RULES AND GUIDELINES

- Rebates are available for high efficiency HVAC equipment meeting program requirements. Only standard split-system air conditioning and heat pump equipment qualify for rebates. New window, through-wall, or portable air conditioners do not qualify for rebates.
- The Program Participant agrees to abide by all applicable Local, State and Federal guidelines, laws, building codes, regulations and licensing requirements and to install the eligible equipment according to manufacturer specifications and program guidelines.
- The Program Participant agrees that the use of the Dayton Power and Light (DP&L) name or logo by the Program Participant must be authorized in writing by Conservation Services Group (CSG) program staff, prior to use. The Program Participant also agrees to allow its company's name to appear on the DP&L web site in the Participating Contractor list and to allow this list to be circulated to prospects.
- The Program Participant agrees to provide proof of HVAC license, adequate liability insurance, BWC certificate of premium payment, and B- or better rating from the Better Business Bureau.
- The Program Participant agrees to reduce the invoiced charges to the DP&L customer by an amount equal to the incentive and to show that reduction on the invoice, labeled as the "DP&L Heating and Cooling Rebates." Payment of the incentives will be consolidated and made directly to the Program Participant twice each month. Incentive Applications must be turned in within thirty (30) days of when the work was completed.
- The Program Participant acknowledges that single family living units may be eligible for multiple incentives, but that residences receiving two or more incentives will be automatically flagged for program compliance auditing. Single family living units served may include only single-family detached homes, single-family attached homes, and mobile homes.
- The Program Participant agrees to random "spot check" inspections by a DP&L Heating and Cooling Rebates representative for verification purposes.
- The Program Participant will be responsible for the proper disposal of all materials, including hazardous materials.
- The Program Participant agrees to indemnify and hold harmless DP&L and DP&L's program implementation contractor, CSG from any claims which might arise as a result of the intentional or negligent acts of the Program Participant.
- Participation in the DP&L Heating and Cooling Rebates is voluntary and may be terminated by either party at any time or for any reason without penalty with written notice.
- Nothing in this agreement shall construe any subcontractor relationship between the Program Participant and either DP&L or CSG.
